FOIA 2021-0095-F requested photographs and video footage from tapes WHTV 862 and WHTV 863 of the State of the Union Address delivered by President George W. Bush on January 29, 2002

This FOIA contains video of President George W. Bush entering the House of Representatives chamber of the United States Capitol, delivering the State of the Union Address, and exiting the chamber on January 29, 2002. This FOIA also contains photographs of President George W. Bush being greeted at the U.S. Capitol, waiting in a holding room, greeting members of Congress, Joint Chiefs of Staff and Supreme Court Justices, and delivering the State of the Union

Address on January 29, 2002. Photographs also depict Mrs. Laura Bush and guests including Hamid Karzai, Chairman of the Afghan Interim Authority.

System of Arrangement

The materials in FOIA 2021-0095-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program.
