FOIA 2023-0006-F requested electronic records to or from Byron Johnson between January 1, 2001 and January 1, 2003.

This FOIA primarily contains email correspondence about selecting individuals to serve as panel participants and guests for events hosted by the White House Office of Faith-Based and

Community Initiatives. Additional email correspondence includes solicitations to participate in various grant writing workshops as well as copies of the booklet "Objective Hope: Assessing the Effectiveness of Faith-Based Organization: A Review of the Literature" by Byron Johnson.

System of Arrangement

The materials in FOIA 2023-0006-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
