### **Scope and Content**

The materials in FOIA 2023-0007-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2023-0007-F requested electronic records to or from Byron Johnson between January 2, 2001 and June 30, 2003.

This FOIA primarily contains email correspondence about selecting individuals to serve as panel participants and guests for events hosted by the White House Office of Faith-Based and Community Initiatives (OFBCI). Additional email correspondence includes meeting arrangements to discuss Byron Johnson's upcoming research into Faith-Based Organizations. Copies of the booklets "American Piety in the 21st Century," "A Better Kind of High: How Religious Commitment Reduces Drug Use Among Poor Urban Teens," "The Role of African-

American Churches in Reducing Crime Among Black Youth," and "Objective Hope: Assessing the Effectiveness of Faith-Based Organization: A Review of the Literature" all by Byron Johnson are also present.

#### System of Arrangement

The materials in FOIA 2023-0007-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2023-0007-F:

#### George W. Bush Electronic Records

33Days contains 6 assets, of which 5 are released in full and 1 is withheld in full. Exchange contains 33 assets, all of which are released in full. RNCPST contains 2 assets, all of which are released in full.
