## Scope and Content

The materials in FOIA 2018-0263-F[40] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[40] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing abort between July 2003 and May 2006.

This FOIA primarily contains veto threat summaries, Freedom Corps greeter information and Air Force One biographies, weekly legislative reports, a trafficking in persons Memorandum for the President, a Memorandum for the Secretary of State regarding the Transfer of Funds from International Organizations and Programs (IO&P) funds to the Child Survival and Health

Programs Fund, messages from the Federalist Society, draft robo letter information, news articles, emails regarding a news article, and a briefing paper and draft remarks regarding the signing of the Partial Birth Abortion Ban. Records from this segment date from July 11, 2003 through November 4, 2003.

#### System of Arrangement

The materials in FOIA 2018-0263-F[40] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

#### George W. Bush Electronic Records

Abort Exchange\_1b contains 143 assets, of which 72 are released in full and 71 are withheld in full.

Abort Exchange\_2a contains 177 assets, of which 126 are released in full, 35 are withheld in full, and 16 are withheld in part.
