# Scope and Content

The materials in FOIA 2018-0263-F[43] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[43] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing abort between July 2003 and May 2006.

This FOIA primarily contains news articles, speech drafts and messages with edits, briefing papers, political briefings, administrative emails, pool reports, draft statements of administration policy, gift reports, White House Comment Line monthly reports, presidential correspondence monthly reports, night notes, legislative weekly reports, and records related to a Supreme Court

vacancy such as articles, blogs, and discussion of executive privilege on Roberts' documents. Records from this segment date from January 6, 2005 through August 31, 2005.

#### System of Arrangement

The materials in FOIA 2018-0263-F[43] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
