Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2022-0079-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2022-0079-F requested materials related to David Gibbons Cannon.

This FOIA primarily contains schedules, memoranda, guest lists, reports, information sheets, and photographic prints. The textual materials are largely focused on President George W. Bush's appearance at the Kennedy Center Honors Gala held on December 7, 2003. There are multiple schedules, guest lists, and briefings for the event, as well as biographies for the Gala's honorees. In addition, there are daily schedules for President George W. Bush from December 2003 and event memoranda for a White House reception for the Kennedy Center honorees, a photo opportunity with White House social aides, and the White House official holiday portrait.

Electronic records consist of news articles, reports, press releases, mailing lists and labels, guest lists, briefing points and a court opinion from the US Court of Appeals for the Fourth Circuit: Hodges v. Abraham, et al. The bulk of the electronic materials are related to President George W. Bush's appearance at the Kennedy Center Honors Gala held on December 7, 2003.

System of Arrangement

The materials in FOIA 2022-0079-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and George W. Bush Presidential Electronic Records.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) and folders processed in response to FOIA 2022-0079-F:

George W. Bush Electronic Records

- 21 Days contains 3 assets, of which 1 is released in full, and 2 are withheld in part.
- 33 Days contains 5 assets, all of which are released in full.
- 40 Days contains 12 assets, of which 3 are released in full, and 9 are withheld in full.

ARMS contains 97 assets, of which 24 are released in full, 2 are withheld in part, and 71 are withheld in full.

Exchange contains 342 assets, of which 125 are released in full, 30 are withheld in part, and 187 are withheld in full.

RNC_PST contains 132 assets, of which 14 are released in full, 4 are withheld in part, and 114 are withheld in full.

OA contains 15 assets, of which 2 are released in full, and 13 are withheld in full.

OPD contains 2 assets, both of which are withheld in full.

WAVES contains 1 asset, which is released in full.

WHO contains 45 assets, of which 11 are released in full, and 34 are withheld in full.
