Scope and Content

The materials in FOIA 2018-0263-F[46] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[46] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing abort or pro-life between July 2003 and May 2006.

This FOIA primarily contains night notes, speech drafts, comment line reports many of which relate to Terry Schiavo, articles with commentary, cabinet reports, moot schedules, briefing papers, gift reports, a memorandum on Plan B Emergency Contraceptive, and information on judicial nominees. Records from this segment date from July 10, 2003 to January 10, 2007.

System of Arrangement

The materials in FOIA 2018-0263-F[46] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

George W. Bush Electronic Records

Abort Exchange_8 contains 79 assets, of which 55 are released in full, 20 are withheld in full, and 4 are withheld in part.

Abort RNCPST_1 contains 229 assets, of which 216 are released in full, 7 are withheld in full, and 6 are withheld in part.

Abort RNCPST_2 contains 156 assets, of which 87 are released in full, 0 are withheld in full, and 69 are withheld in part.

Abort RNCPST_3 contains 3 assets, of which 1 is released in full and 2 are withheld in full.

Pro Life 40Days contains 6 assets, all of which are released in full.

Pro Life ARMS contains 1 asset, which is released in full.

Pro Life Exchange contains 194 assets, of which 161 are released in full, 14 are withheld in full, and 19 are withheld in part.
