Scope and Content

The materials in FOIA 2017-0356-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2017-0356-F requested Staff Member Office Files related to Christopher Wray.

This FOIA primarily contains documents pertaining to political appointments for Christopher Wray during the Bush Administration. Materials include copies of Wray's resume, nomination forms, correspondence, and a printed copy of a journal article co-authored by Wray.

System of Arrangement

The materials in FOIA 2017-0356-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in this collection area – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
