FOIA 2017-0372-F requested White House Office of Records Management (WHORM) files that contain any reference to Jennifer Newstead.

This FOIA primarily contains memoranda, correspondence, executive orders and drafts thereof, news articles, briefing papers, schedules, lists, charts, speeches and drafts thereof. Included in these materials are messages sent to and received from the general public on a variety of subjects. Also included in these records is a January 2003 Executive Office of the President Telephone Directory.

System of Arrangement

The materials in FOIA 2017-0372-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.
