Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2024-0023-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2024-2023-F requested materials related to White House Staff Member Office Files for Stephen Friedman pertaining to tax or taxes.

This FOIA primarily contains research papers, website printouts, published articles and reports, printed emails, talking points, and memoranda. These textual records focus on comparing tax savings across income groups resulting from key provisions of the 2001 and 2003 tax cuts and President George W. Bush's actions to promote tax reform.

System of Arrangement

The materials in FOIA 2024-0023-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
