FOIA 2024-0024-F requested materials related to White House Staff Member Office files for N. Gregory Mankiw pertaining to tax or taxes.

This FOIA primarily contains printed remarks from the files of N. Gregory Mankiw. This request features two transcripts for remarks provided by N. Gregory Mankiw at two separate occasions between 2003 and 2005. These events were the Tax and Economy Meeting and the TCPI (Tax Council Policy Institute) Symposium.

System of Arrangement

The materials in FOIA 2024-0024-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
