Scope and Content

The materials in FOIA 2024-0027-F are a selective, not necessarily all-encompassing, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2024-0027-F requested materials related to White House Staff Member Office files for Karen Hughes pertaining to tax or taxes.

This FOIA primarily contains memorandums, statistical analyses of taxes, copies of tax returns, and interpretations from White House staff members. The memorandums encompass personnel discourse surrounding the state of taxes in the United States, as compared to President George W. Bush's Tax Relief Plan. The statistical analyses were prepared by Merril Lynch & Co. Inc. The tax returns are copies of President George W. Bush's tax return from 2001, filed in 2002.

System of Arrangement

The materials in FOIA 2024-0027-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
