#### **Extent**

692 folders, approximately 48,704 pages / 1,522 assets

#### Access

Collection is open to all researchers. Access to George W. Bush Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

#### **Scope and Content**

The materials in FOIA 2014-0142-F[1] are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0142-F[1] requested materials pertaining to the proposed dismissal or replacement of United States Attorneys in November and December 2006.

The first segment of this FOIA primarily contains production documents provided to Congress and the Department of Justice per subpoena requests. A vast majority of the production documents consist of routine email printouts from the Exchange Email system. Also present within the production documents are news articles and press releases, Congressional hearing transcripts, and several letters between White House officials and members of Congress

requesting information about the dismissed United States Attorneys, and correspondence from the Department of Justice describing its response to these requests. Statements and talking points and drafts thereof are included. Electronic records consist of news articles, press releases, and statements. Additionally, there are emails from United States Attorneys confirming their retirement and emails setting up swearing-in ceremonies for new federal employees. Also, there are letters and reports from the Government Accountability Office regarding federal vacancies and appointments as well as correspondence between White House officials and members of Congress.

# **System of Arrangement**

The materials in FOIA 2014-0142-F[1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas –White House Office of Records Management (WHORM) Subject Files, Staff Member and Office Files, and George W. Bush Presidential Electronic Records.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
