FOIA 2017-0384-F requested materials related to records of the White House Office of Speechwriting between 1/20/2001 and 1/31/2005 concerning the Annual March for Life, National Catholic Educational Association, National Right to Life Committee, Priests for Life, Thomas More Society, and United States Conference of Catholic Bishops Secretariat of Pro-Life Activities.

This FOIA primarily contains drafts of speeches, printed webpages, and printed emails.

System of Arrangement

The materials in FOIA 2017-0384-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
