Scope and Content

The materials in FOIA 2019-0022-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2019-0022-F requested materials related to Donald Trump. Records include materials re-reviewed that were previously closed under Presidential Records Act restrictions in other FOIA requests.

This FOIA primarily contains emails re-reviewed from 2016-0243-F and 2016-0244-F and include draft examples for OMB, discussion of a HUD public service announcement, a draft thank you letter to Donald Trump, a State of the Union proposal, a draft fact sheet, suggested changes to a FDIC proposal, discussion of an invitation to speak at an annual meeting, discussion of an employee appearing on The Apprentice, a draft briefing for video tapings, an email from

Karen Hughes discussing a phone call and request from Donald Trump, and discussion of an appearance on the Tonight Show for Condoleezza Rice.

System of Arrangement

The materials in FOIA 2019-0022-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

2016-0243-F Exchange contains 89 assets, of which 57 are released in full, 17 are withheld in part, and 15 are withheld in full.

2016-0243-F Exchange 40 Days contains 4 assets, all of which are released in full.

2016-0244-F ARMS contains 4 assets, all of which are withheld in full.

2016-0244-F Exchange contains 91 assets, of which 76 are released in full, 15 are withheld in part, and 0 are withheld in full.

2016-0244-F Exchange 40 Days contains 1 assets, which is released in full.
