Scope and Content

The materials in FOIA 2023-0252-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2023-0252-F requested materials related to FG001-07 briefing papers dated November 18, 2005 through November 25, 2005 and March 19, 2006 or referencing Haditha, Wuterich or Chessani.

This FOIA primarily contains schedules, block schedules, narratives, event memorandums, contact sheets, and briefings specific to the president's travels. The materials include detailed agendas for President George W. Bush and First Lady Laura Bush, according to the respective occasions. The events featured were commencements, visits to military bases, presidential duties for congressional influence, and visits with soldiers' families.

System of Arrangement

The materials in FOIA 2023-0252-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
