Scope and Content

FOIA 2024-0079-F requested materials related to the National Association of State Catholic Conference Directors held on Thursday, December 4, 2003.

This FOIA primarily contains correspondence, website printouts, facsimiles, and memoranda. It also contains electronic records consisting of emails, agendas, remarks, and memoranda about the conference.

System of Arrangement

The materials in FOIA 2024-0079-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in this collection area – White House Office of Records Management (WHORM) Subject Files and George W. Bush Presidential Electronic Records.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
