#### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Scope and Content**

The materials in FOIA 2025-0031-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2025-0031-F requested materials related to the 2006 State of the Union address, focused on the phrase "America is addicted to oil, which is often imported from unstable parts of the world," and the subsequently mentioned goal of replacing "more than 75 percent of oil imports from the Middle East by 2025" dated November 1, 2005 – February 15, 2006 from the CEA, NSC, and OPD shared drives.

This FOIA primarily contains memoranda, draft talking points, published materials, a briefing paper, and a budget summary and analysis.

## **System of Arrangement**

The materials in FOIA 2025-0031-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
