Scope and Content

The materials in FOIA 2018-0156-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0156-F requested textual materials related to President George W. Bush's Administration's priorities and efforts for counterterrorism cooperation with Pakistan.

This FOIA primarily contains correspondence, memorandum, printed emails, briefing papers, speech drafts, routing memos, schedules, handwritten notes, press briefings, and presentations. The records cover a wide range of topics, including: the Global War on Terrorism; a Department of Defense program to build capacity of foreign military forces; threats to the U.S. homeland; the Middle East; Pakistan; counterterrorism efforts; the Iraq War; the 9/11 Commission; the Afghanistan War; and President George W. Bush's trips to Poland, the FBI Academy, and West Point.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2018-0156-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.
