Scope and Content

The materials in FOIA 2019-0164-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2019-0164-F requested records to or from any White House, Treasury Department, Congressional, or Federal Reserve email addresses mentioning Elizabeth Warren between January 20, 2001 and December 31, 2007.

This FOIA primarily contains published news articles, studies, and papers quoting Elizabeth Warren in her role as Harvard Law School professor and expert in the field of debt, credit, lending, and bankruptcy; Warren's 2005 testimony before the Senate on bankruptcy reform; and a September 2006 report written by Elizabeth Warren and Amelia Warren Tyagi with critique and comments.

System of Arrangement

The materials in FOIA 2019-0164-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

ARMS contains 9 assets, of which 7 are released in full and 2 are withheld in full.

Exchange contains 92 assets, of which 85 are released in full, 1 is withheld in part, and 6 are withheld in full.

33 Days contains 4 assets, all of which are released in full.

40 Days contains 9 assets, of which 8 are released in full and 1 is withheld in full.

RNC_PST contains 4 assets, all of which are released in full.
