FOIA 2025-0047-F requested video footage of Azerbaijani President Heydar Aliyev and President George W. Bush meeting in the Oval Office on February 26, 2003.

This FOIA primarily contains five video clips from tape WHTV 2042 Photo Op Tape #1 for 02/24/2003 - 03/02/2003 including a photo opportunity for Saturday Night Live Crew on February 24, 2003 in the Oval Office, a meeting with the Prime Minister of Bulgaria on February 25, 2003 in the Oval Office, a meeting with the National Economic Council and remarks to the

press on February 25, 2003 in the Cabinet Room, a meeting with the President of Azerbaijan on February 26, 2003 in the Oval Office, and a credential ceremony for newly appointed ambassadors on February 26, 2003 in the Oval Office.

### **System of Arrangement**

The materials in FOIA 2025-0047-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
