In terms of comparison stats, we frame those this way.

1. In both the Bush 41 and Clinton Administration, too many appeals court nominees were held up at the end of the Administrations. In the Bush 41 Administration, only 19 of 29 appeals court nominees in the last two years were confirmed; in Clinton, it was 15 of 29. Neither was acceptable -- as this President Bush has explained.

2. In this Administration, the difference is that the Senate delays and obstruction started at the beginning of the Administration. In particular, only 53% of President Bush's appeals court nominees in his first 2 years (17 of 32) were confirmed compared to more than 90% (60 of 65 total) in the Clinton, Bush 41, and Reagan Presidencies combined during the first two years of those Presidencies. And now we are seeing unprecedented filibusters of multiple nominees.
