BACKGROUND: Judge Terry O'Brien of Wyoming is supported by both Wyoming Senators, and served as a state trial judge for 20 years.

TOPICS OF DISCUSSION:

1. Inform him of the nomination and congratulate him.
2. Thank him for agreeing to serve.
3. Caution him on the confirmation process, which may be lengthy and difficult, and affirm the Administration's support for him in that process.
