Subject: Stop the Nomination of Justice Pricilla Owen

The Senate Judiciary Committee is considering the nomination of Texas State Justice Pricilla Owen to the Fifth Circuit Court of Appeals. Owen's record is that of a right-wing ideologue with views so extreme that even the other Republican Justices on the Texas State Supreme Court disagree with her.

Owen's presence on the Fifth Circuit will undermine women's right to abortion. Her opinions as a Texas State Supreme Court Justice show that she is hostile to abortion rights, will support law maker's attempts to limit women's access to abortion, and will create obstacles not even considered by law makers in order to make it more difficult for a woman to have a safe, legal abortion.

Owen is being opposed by a coalition of women's rights and civil rights groups including the Feminist Majority, the National Organization for Women, People for the American Way, and the Leadership Conference on Civil Rights.

Urge Members of the Senate Judiciary Committee to reject this nominee who has consistently ruled to limit abortion access.
